Art. 1

Number and type of scholarships

The La Sapienza Foundation for the Promotion of Study and Research announces a competition for the award of a scholarship of € 14.285,00 for the year 2022, gross of charges to be paid by the beneficiary. The scholarship, promoted and financed by CERI Research Center "Forecasting, Prevention and Control of Geological Risks" - Sapienza University of Rome, is intended for foreign graduates (Master of Science) in "Engineering Geology", who have published scientific papers and/or who have defended the master thesis in the field of land use and georesources management and planning, through Remote Sensing and GIS techniques.

Art. 2

General admission requirements

They are admitted to the competition - pursuant to art. 1 - foreign citizens, in possession of a degree (Master of Science) who have published scientific papers and/or who have defended the master thesis in the field of land use and georesources management and planning, through Remote Sensing and GIS techniques at a foreign university. Application, methods of presentation and qualifications that can be assessed

The candidate will have to send, under penalty of exclusion, by e-mail:

The requirements must be possessed by the date of expiry of the call, under penalty of exclusion.

The documents may be produced in copies declared authentic by substitutive declaration of

the deed of notoriety, pursuant to Presidential Decree 445/2000 (Annex B, in pdf format). The Foundation reserves the right to carry out appropriate checks on the veracity of the content of the certificates attached to the application presented by those who are awarded the scholarships.

Applications received in a manner other than that indicated above will not be admitted to the competition.

Art. 4

Judging Commission

The President of the La Sapienza Foundation for the Promotion of Study and Research appoints the Judging Commission of the selection procedure, composed of at least three members chosen, on the proposal of the Board of Directors of the Foundation itself, from among professors who are members of the Scientific Council and / or professors of the scientific area of the subject of the insolvency procedure.

The Selection Committee, having verified the possession by the candidates of the requisites referred to in art. 2, has wide discretion on the criteria to be adopted for the evaluation of candidates.

If the Commission does not identify deserving candidates, the scholarship will not be awarded.

If the number of candidates in possession of the requisites exceeds the number of scholarships available, the Jury proceeds with the formulation of a ranking in order of merit and has the possibility of dividing the scholarship equally among several candidates.

The Commission's judgment is unquestionable.

The minutes drawn up by the Commission will be sent, with the relative attachments, to the Secretariat of the President of the Foundation and will be kept by the same.

Art.5

Outcome of the procedure

The outcome will be communicated to the interested parties by advertising on the website of the Rome Sapienza Foundation.

The winners of the competition will be notified to the email address indicated in the registration form and the scholarship will be paid in a single installment. The annual certification award ceremony will be communicated to the winners in advance.

Art. 6

Incompatibility

The scholarship is incompatible with other scholarships / awards, provided by the Sapienza Foundation, received in the same year or in previous years, having the same object.

The personal data provided by the candidates will be processed exclusively for the purposes of managing the competition procedure.

Art. 8
